



ICE 22 LIMITED SUPPLEMENTAL WARRANTY

Starzec Energy Efficiency Solutions, LLC (SEES), an exclusive and authorized reseller of ICE 22, hereby offers the purchaser of ICE 22 (Purchaser) a Limited Supplemental Warranty covering the compressor of any air conditioning unit (Unit) in which ICE 22 is professionally installed by an authorized ICE 22 installer, subject to the terms and conditions below:

1. The Supplemental Warranty is in addition to, and not in lieu of, the original manufacturers warranty. Before the coverage of the Supplemental Warranty can be invoked, all efforts to gain repairs under the original manufactures warranty must be exhausted.
2. The Supplemental Warranty is restricted to damage to the compressor solely attributable to the use of ICE 22. Any damage to the compressor not solely attributable to ICE 22 or damage to any component other than the compressor is not covered under the Supplemental Warranty.
3. The Supplemental Warranty only covers the compressor of the air conditioning Unit. Parts and labor are not included. The type and brand of replacement compressor or Unit is at SEES sole discretion.
4. The Supplemental Warranty does not cover compressor failure due to past damage, Purchaser neglect, abuse or improper maintenance or any acts of God.
5. SEES is not liable for any special or consequential damages of any kind, including, but not limited to loss or damage of non-compressor property, loss of profit, revenue or business opportunity, and the cost of replacement equipment, excluding the compressor. The remedies to the Purchaser are exclusive. The liability of SEES is limited to the cost of a replacement compressor. By accepting this Supplemental Warranty, the Purchaser hereby waives any and all other rights or available remedies and accepts the remedy of a replacement compressor as the sole and express remedy.

Period of Coverage:

1. If Purchaser's Unit is currently covered by the original manufacturers warranty, the Supplemental Warranty will extend to the end of the original manufacturers warranty.
2. If Purchaser's Unit is not currently covered by the original manufacturers warranty and is less than seven (7) years old from the date of original installation, the Supplemental Warranty will extend one (1) year from the date of installation of ICE 22.
3. If the Purchasers Unit is more than seven (7) years old and less than ten (10) years from the date of original installation, the Supplemental Warranty will extend for a period of ninety (90) days from the date of installation of ICE 22.

THE LIMITED SUPPLEMENTAL WARRANTY AND LIABILITY SET FORTH HEREIN ARE IN LIEU OF ALL OTHER WARRANTIES AND LIABILITIES, WHETHER IN CONTRACT OR IN NEGLIGENCE, EXPRESS OR IMPLIED, IN LAW OR IN FACT, INCLUDING BUT NOT SPECIFICALLY LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR PARTICULAR USE, AND IN NO EVENT SHALL WARRANTOR BE LIABLE FOR ANY INCIDENTAL, INDIRECT, SPECIAL OR CONSEQUENTIAL DAMAGES.



Some states do not allow limitations on how long an implied limited warranty lasts or do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. This limited warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

Warranty Activation:

1. The warranty must be activated by the Purchaser no later than sixty (60) days from the date of installation of ICE 22.
2. Activation is made easy, via the web at www.ice22.com or by completion of the Limited Supplemental Warranty registration that is included in your installation data.
3. By activating the Limited Supplemental Warranty, the Purchaser expressly agrees to all of the terms and conditions set forth above.
